Section 60-15 of the TASA allows the TPB to do anything incidental or conducive to the performance of its functions, which includes the collection of information in relation to an applicant's relevant tax (financial) advice experience for the purposes of registration under the TASA.

The personal information collected will be used and stored in accordance with the APPs.

If you do not provide the requested information, we may not be able to process the application.

Some of the information collected from you may be provided to other government agencies including the Australian Taxation Office and Australian Securities and Investments Commission and third parties relevant to the application.

This may occur, for example, in order to verify the information you have provided and only where we are authorised under the TASA to do so and it is considered to be relevant to the processing of the application.
